**RESOLUTION TO ESTABLISH MILLAGE RATE FOR FIRE
PROTECTION SPECIAL ASSESMENT DISTRICT**

At a Regular Meeting of the Township Board of Scio Township, Washtenaw County, Michigan, held at the Scio Township Hall, 827 N Zeeb Road, in said Township, on March 19, 2024, at 7:00 pm.

Members Present: Brazeau, Flintoft, Hathaway, Kerry, Knol, Palmer, Reiser

Members Absent: None.

The following preamble and resolution were offered by Clerk Flintoft and supported by Trustee Reiser.

WHEREAS, the Township has determined that providing fire protection is in the best interest of the public health, safety, and welfare of the Township residents; and

WHEREAS, pursuant to the Township Police and Fire Protection Act, Act 33 of 1951, a township may provide that the cost of purchasing and housing equipment and general operations for fire protection may be defrayed by special assessment; and

WHEREAS, on May 9, 2023, the Township Board tentatively established the Special Assessment District and on June 13, 2023, held the required Public Hearing;

WHEREAS, on August 8, 2023, the Township Board provided a hearing for any objections to the Special Assessment District being created;

WHEREAS, on August 8, 2023, the Township Board set three proposed Special Assessment District tax rolls to be assessed in 2023 and in the amounts of 1.35 mill, 3.75 mill, and .75 mill, and on September 12, 2023, those tax rolls were confirmed by the Township Board;

WHEREAS, on November 5, 2019, the Scio Township electorate decided to approve a fire protection special assessment levy of 1.35 mill;

WHEREAS, the Township Police and Fire Protection Act, Act 33 of 1951, requires that the township board, shall annually hold a hearing on the estimated costs and expenses of police and fire protection and on the distribution of the levy;

WHEREAS, the Township Board held a public hearing on March 5, 2024 at the Scio Township Hall to consider proposed expenses from the special assessment and to set the millage rate for the special assessment district based on the proposed expenses;

NOW, THEREFORE BE IT RESOLVED THAT, the Township Board has reviewed and considered the proposed expenses for the proposed Fire millage, and,

BE IT FURTHER RESOLVED THAT, the December 1, 2024, assessment is recognized as revenue in Fiscal Year 2025, and,

BE IT FINALLY RESOLVED THAT, the millage rate is set as follows: 1.35.
