**RESOLUTION TO DIRECT THE CLERK TO SUBMIT THE ADOPTED BALLOT PROPOSAL
LANGUAGE TO RENEW AND RESTORE THE TRANSPORTATION MILLAGE AND FOR IT TO
BE PLACED ON THE AUGUST 6, 2024, BALLOT**

At a Regular Meeting of the Township Board of Scio Township, Washtenaw County, Michigan, held at the Scio Township Hall, 827 N Zeeb Road, in said Township, on April 9, 2024, at 7:00 pm.

The following preamble and resolution were offered by Trustee Reiser and supported by Supervisor Hathaway.

WHEREAS, in 2015, the electorate of Scio Township approved a ballot proposal establishing a Transportation Millage; and

WHEREAS, the term of the Millage was from 2015 through 2024; and

WHEREAS, the Township recognizes that the Transportation Millage is an important source of funding that benefits the residents of Scio Township; and

WHEREAS, the Millage is set to expire at the end of 2024; and

WHEREAS, the Millage rate has been decreased from its original amount by the Headlee rollback process.

NOW, THEREFORE, BE IT RESOLVED THAT, the Scio Township Board of Trustees directs the Clerk to submit the following Transportation Millage proposal ballot question language that was approved on April 9, 2024, to be placed on the August 6, 2024 State Primary Election ballot:

Shall the Transportation Millage approved in 2015 for a period of ten (10) years be renewed and restored to impose on taxable property in the Township of Scio, County of Washtenaw, Michigan, 0.3627 mill (\$0.3627 per thousand dollars of taxable value) for a period of ten (10) years, 2025 to 2034 inclusive, for the purpose of providing funds for public transportation services in Scio Township? It is estimated that 0.3627 mill would raise approximately \$616,980 when first levied.
